Further, it is explicitly informed that before joining the bank, the candidates should ensure the eligibility and availability of documents such as qualification certificate/s, experience certificate/s, caste certificate, Mandatory Experience of Branch Manager / Branch Head etc. In case, it is observed that any provisionally selected candidate does not fulfil eligibility criteria or conceal the information with respect of eligibility, his / her candidature will stand cancelled at any stage i.e. prior to joining the Bank or even after joining to Bank. The candidates who fail to produce required original documents will not be allowed to join the Bank.

Mere eligibility / admission to interview does not imply that the Bank is satisfied beyond doubt about the candidate's eligibility and shall not vest any right in a candidate for selection. The Bank would be free to cancel the candidature of any candidate at any stage of recruitment process, if he / she is found to be ineligible and / or furnished incorrect or false information / certificates / documents or has suppressed any material facts and the fees paid by the ineligible candidates shall be forfeited. If appointed, such candidates may be summarily removed from the services of the Bank.

The provisionally selected candidates must, therefore, ensure that they fulfil all the notified eligibility criteria as on the cut-off date prescribed in aforesaid recruitment notification, have possession of the requisite documents / certificates specified by the Bank, and that the particulars furnished in their Online Application are complete, true and correct in all respects. Bank may verify the eligibility of the candidates at any stage of recruitment process or thereafter and **reserves right to terminate from service of provisionally selected candidates if found ineligible for the post.**
