**Reg: - Extension for Renewal of IBA Retiree Insurance Policy 2019-20**

This has reference to our circular No. AX1/Staff/Welfare Cell/IBA Group Med.Ins./Cir.69/2019 dated 4<sup>th</sup> October, 2019 & AX-1/ST/Welfare/Cir No.80/2019 dated 23th October 2019 regarding Renewal of policy for the IBA Group Mediclaim Insurance for Retirees' for 2019-20 from 01.11.2019 to 31.10.2020 (existing Policies expired on 31st October, 2019). As per the said circular the last date for punching the option was 25.10.2019.

The United India Insurance Company Ltd has now extended the last date for joining / renewing the scheme till 25.11.2019.

All the retired employees / spouses of retired employees who have not opted to join the scheme earlier and wish to join the scheme can punch their willingness the same in ULC through the pension drawing branch or nearest branch of the Bank. The navigation for this link is given below-



The last date for punching the data by the pensioners is 25.11.2019. The retirees who joins the scheme by punching the data on or before 25.11.2019 will have to maintain sufficient balance in their account so as to enable the HRM Dept to debit the required premium amount. Please note that the circular is applicable only for retired employees / spouses of retired employees who have not opted to join the scheme or renewed their option earlier.
