**"PLEASE NOTE THAT THE IFSC/ MICR CODES OF MERGED BRANCHES WILL BE DELETED FROM SYSTEM SUBSEQUENT TO MERGER".** Hence, all are requested to kindly use IFSC / MICR code of parent/ base branch for all kind of transactions from 14/01/2019 onwards.
