Sealed item rate tenders are invited from **empanelled contractors of Bank of Maharashtra** for Proposed internal & external painting, toilet works and miscellaneous essential civil works to be executed at Zonal Office, Mahabank Building and Annexe Bulding Sitabuldi, Nagpur The total work is to be completed within <u>90</u> days time from the date of **work order**.

The blank tender document shall be available at **Bank of Maharashtra**, **Nagpur Zonal Office**, **Mahabank Building**, **Sitabuldi**, **Nagpur** during office hours (Monday to Friday 10.30 a.m. to 5.30 p.m. and 10.30 a.m. to 2.00 p.m. on Saturday) on payment of **Rs. 3000** /-(**Rupees Three Thousand only**) as cost of tender form. The blank Tender form can also be downloaded from website but while submission of Tender shall be accompanied by Demand Draft/Pay order of **Rs. 3000/-(Rupees Three Thousand Only)** as the cost of Tender form in the name of **"BANK OF MAHARASHTRA"** payable at **Nagpur** which is non-refundable,

The <u>blank tender form</u> shall be available from dated <u>12-11-2014 to 26-11-2014</u> during office hours upto <u>17.30 Hrs on 26-11-2014</u> and they are to be submitted at the **above address on or before 01-12-2014 up to 15.30 Hrs.** duly filled in along with a **Demand Draft/Pay order** drawn on any Nagpur City Branch for **Rs. 57,000/- (Rupees Fifty Seven Thousand Only.)** in the name of **"BANK OF MAHARASHTRA"**, towards **Earnest money deposit**.

The tender will be opened on <u>01-12-2014</u> at <u>16.00</u> Hrs. in the presence of the contractors present at that time. Tenders without Earnest money deposit will not be considered and shall be out rightly rejected.

Tenders received Late after the date and time of Submission either personally or by post or postal delay will not be considered and summarily will be treated as rejected.

Bank Of Maharashtra reserves the right to accept or reject any or all tenders either in whole or in part, without assigning any reasons.

SPECIAL CONDITIONS OF THE CONTRACT:-

- 1. The tender is to be properly filled and endorsed and to be quoted in full.
- 2. The contractor should quote in figures as well as in words the rate and amount tendered by them. The amount for each item should be worked out and the requisite totals given.
- 3. THE CONTRACTORS SHALL QUOTE THE EXACT WORKING RATES OF ITEMS & <u>NO</u> <u>REBATE / DISCOUNT IN PERCENTAGES</u> SHALL BE CONSIDERED AS IT IS AN ITEM RATE TENDER WITH THE PRICE BID, THE RATES QUOTED WILL ONLY BE TAKEN INTO ACCOUNT. HOWEVER DURING THE PERIOD OF NEGOTIATION IF ANY AS THE AUTHORITIES MAY DEEM FIT TO SHALL BE CONSIDERED DURING THE PROCESS OF NEGOTIATIONS WHILE ACCEPTANCE OF THE TENDER.
- 4. The rates to be quoted are on item rate basis and are to be inclusive of everything including all the taxes involved viz octroi, sales tax, Vat, works contract tax, excise duty, material cost, labour, etc. complete.
- 5. Blank Tender forms shall be available upon payment of <u>Rs. 3000 /- (Rupees Three Thousend</u> <u>only)</u> as tender fees, which is non-refundable.

6. <u>Earnest Money and Security Deposit</u>

An amount of **Rs. 57,000/- (Rupees Fifty Seven Thousand Only.)** shall be paid by Demand draft/Pay order as Earnest Money Deposit at the time of tendering in the name of the bank. On acceptance of Tender and offer letter of work, the successful tenderer shall deposit a further amount to make it 2% of approved Tendered amount with the bank as initial security deposit. No interest is liable to be paid by the Bank on the above deposits.

7. Tender's acceptance:

The Bank reserves the right to accept / reject any or all tenders without assigning any reasons for rejection/acceptance whatsoever.

The tenderer whose tender is accepted will have to enter in to an agreement immediately on being informed to do so. In case of failure on the part of tenderer to sign the agreement within the stipulated time, the earnest money paid by him shall stand forfeited to bank and the offer of the tenderer shall be considered as withdrawn by him.

- 8. The work is to be carried out in the existing Zonal Office Premises & the time period provided forcompletion of work is inclusive of load shedding hours & aforesaid constraints. The contractor should make his own alternative arrangements at his own cost to compensate with load shedding hours & no additional remuneration shall be paid for such arrangements nor any additional time will be granted on this accounts.
- 9. The tenderer shall be presumed to have carefully examined the existing premises, conditions and specifications of the work and have fully acquainted themselves with all details of the site and with all the necessary information and data pertaining to the work prior to tendering for the work.

- 10. The tenderer may in the forwarding letter mention any points he may wish to make clear but right is reserved to reject the same or the whole of the tenders if the same becomes conditional tender thereby.
- 11. All pages of document, conditions, specifications, drawings and plans etc. shall be initialed by the tenderer. The tender should bear full signature of the tenderer.
- 12. The Deputy Zonal Manager or his duly authorized Officer shall open the tenders in the presence of intending contractors who may be present at the time of opening and will enter the amount of tenders in a comparative statement in a suitable form. In the event of a tender being accepted, the contractor shall thereupon, for the purpose of identification sign copies of specifications and other documents. In the event of a tender being rejected the Bank shall refund the amount of earnest money deposited to the tenderer, on his giving a receipt for the return of money.
- 13. The details and the Specifications are only indicative and the schedule of quantities are only tentative. Any changes/additions/deletions/alterations in them shall be accommodated while executing the work without any prejudice. Any extra items or variations upon the schedule items shall be scrutinized by the Architect of the Bank and his decision shall be final and binding in all respects.
- 14. Specifications of various materials and quality of work shall be the essence of the contract along with the time period and these shall be strictly adhered to.
- 15. LIQUIDATED DAMAGES @ RUPEES <u>1000/- (Rupees One Thousand Only)</u> PER DAY SHALL BE CHARGED FOR ANY DELAY IN THE COMPLETION OF THE WORK BEYOND THE STIPULATED TIME AND THIS CLAUSE SHALL BE STRICTLY FOLLOWED.
- 16. Extra items, if any shall be paid on the basis of cost of materials (inclusive of all the Taxes as already mentioned) and labour plus 15% towards overheads and profits and items rates already accepted shall form the basis of this Contract.
- 17. The Bank Authorities at their discretion may delete any part of item or item in full as they may feel necessary during the course of execution and no compensation will be paid /claimed in this regard. The contractor shall not claim any compensation towards such items.
- 18. The work shall be executed by the Contractor at his own risk and responsibility and the Bank shall not be held liable for any accidents/unforeseen events directly/indirectly and the Contractor understands clearly that no claim for any accidents or loss of life whatsoever shall be entertained by the Bank.

Envelope No.1

The first envelope clearly marked, as 'Envelope No.1' shall contain the following Documents.

1) Crossed Demand draft of any Scheduled Bank for the said amount as Earnest Money Deposit.

2) Performance certificates/ work orders from competent authorities of **Bank Of Maharashtra** for **satisfactory completion** of works shall be enclosed

3) Service Tax Certificate shall be enclosed /Service Tax Certificate No. is to be mentioned in the forwarding letter without which the Tender shall be out-rightly rejected .

4) Contractor shall enclose **work completion certificates** for satisfactory completion of similar type of works in last three financial years of Total value of Rs. 30 Lakhs, minimum three works costing of minimum value Rs. 10 Lakhs each / Two works of Total Rs. 30 Lakhs with one works costing minimum value of Rs.10 Lakhs amount or single work of minimum value Rs. 30 Lakhs amount for similar type of Civil, Sanitary Plumbing / Painting Works from any Government department / Semi Government department/ MES department/ Banking organization.

5) Contractor shall enclose and give an undertaking on Rs. 100/- stamp paper that they will submit Labour Licence for Sanitary plumbing works, Civil works & Painting works, and workers compensation insurance policy/ comprehensive insurance for the Labours / workers working on site for Sanitary plumbing works, Civil works & Painting works if he /they are declared successful tenderer. The work is to be carried out in multistoried Buildings having ht. of 20.00 mts. Approx.

Envelope No.2

The second envelope clearly marked, as 'Envelope No.2' shall contain only the completed Tender document/ price bid along with the drawings and details issued with the blank tender forms duly signed by the Contractor should be enclosed.

If the Bank is satisfied with papers enclosed in the first envelope then only the Envelope No. 2 shall be Opened.

<u>Note:</u> - The tenders are to be submitted in two separate sealed envelopes as mentioned above, however if the two separate sealed envelopes are put in one common sealed cover, the contractor shall mention over the common sealed cover that envelope no. 1 & envelope no.2 are inside the common sealed cover. While opening if it is found that the two separate sealed envelopes are not inside the common sealed cover the tender shall be outrightly rejected.

GENERAL & SPECIAL CONDITIONS OF THE CONTRACT & SPECIFICATIONS FOR WORKMANSHIP AND MATERIALS FOR PROPOSED INTERNAL & EXTERNAL PAINTING, TOILET WORKS AND MISCELLANEOUS ESSENTIAL CIVIL WORKS TO BE EXECUTED AT ZONAL OFFICE, MAHABANK BUILDING AND ANNEXE BULDING SITABULDI, NAGPUR.

GENERAL CONDITIONS: -

- 1. The Work Defined In The Schedule Is For Proposed internal & external painting, toilet works and miscellaneous essential civil works to be executed at Zonal Office, Mahabank Building and Annexe Bulding Sitabuldi, Nagpur
- 2. Every page of Tender Document shall be Signed by the Contractor with full dated Signature and Seal.
- 3. Contractor has to quote his rate both in figures and words.
- 4. The entire work is to be finished within <u>90 days</u>. It is expected that the contractor shall carry out the work at site.
- 5. The Defect Liability Period of the work shall be Six months from the Date of Virtual Completion Certificate issued by the Architect of the Bank.
- 6. Four interim payment shall be paid to the contractor till the completion of contract. The minimum amount of the interim payment shall be <u>20% of the Tendered Amount</u>. From the interim bill an amount of 10% of tendered amount will be deducted towards retention amount inclusive of initial Security deposit & Earnest money deposit. The final bills shall be scrutinized within 15 days from the Date of completion, and the period of honoring the same shall be One month. Half of the retention amount i.e. 5% of the work shall be paid with the final Bill. The final 5% retention amount of the work will be kept as Security deposit and will be released only after Six months from the date of virtual completion of work as certified by the Bank's Architect. The retention amount shall carry no interest whatsoever.
- 7. The contractor/s shall not be paid any advance payments.
- 8. While working at the site, contractor shall make his own arrangements for the storage of materials from the point of damage and security. Similarly he shall be responsible for the preservation and maintenance of the premises.
- **9.** Before commencing the work, the contractor shall mark the layout to full size and get same approved from Architect.
- 10. The tender shall remain valid for 90 days.
- 11. Income Tax / TDS and VAT & any other taxes to be deducted at source shall be deducted from the Bill of Contractor as per the Standard norms of Government.
- **12.** Payment of Electricity charges at the Site for execution of work shall be payable by Contractor only.
