A.NOTICE INVITING TENDER

<u>Subject: Empanelment Of Contractors For Civil, Furniture, Electrical & Ac Works For Branches In The State Of Punjab, Union Territory Of J&K And Union Territory Of Ladakh Under Bank Of Maharashtra, Ludhiana Zone.</u>

- Bank of Maharashtra, Ludhiana Zone is in the process of Empanelment of Contractors in Civil, Furniture, Electrical & AC Works. Application forms are invited for empanelment of reputed Civil, Furniture, Electrical & AC contractors, having valid registration with CPWD/MES/PSUs/ Nationalized Banks/ Govt. Sector/State PWD, and reputed Private Institutions in appropriate class.
- 2. Categories for Empanelment.
 - i. Category A Works upto 25.00 lacs
 - ii. Category B Works upto 20.00 lacs
 - iii. Category C Works upto 15.00 lacs
 - iv. Category D Works upto 05.00 lacs
- 3. Bank of Maharashtra proposes to empanel the Contractors in Civil, Furniture, Electrical & AC Works for existing/proposed offices at various locations of Ludhiana Zone. The centers would be located in different location in the state of Punjab, Union Territory of J & K and LADAKH.
- 4. Bank would empanel Contractors in Civil, Furniture, Electrical & AC Works for Ludhiana Zone. The works which are proposed in different locations of the Ludhiana Zone, where Bank's Offices/premises are located and only those applicants who are capable of carrying out works in aforesaid locations only need to submit their application. The empanelment will be applicable initially for the period of Two years from the date of empanelment. However, Bank has discretion to extend the empanelment period for further one year on same terms and conditions.
- 5. The Civil Contractors satisfying the pre-qualification criteria will be empaneled for the Pune Location, subject to meeting their eligibility criteria. Bank at its discretion shall verify the offices of the applicants. The Contractors are requested to furnish details regarding their Company, Organization Chart, Date of Incorporation, Number of employees, Experience etc. as indicated in the application format given in Bank's website.
- 6. The Contractors, who fulfil the above criteria, may download the application Form, from Bank of Maharashtra website www.bankofmaharashtra.in under Notices Tenders. The application forms duly completed in all respects giving the aforesaid information

C.TERMS AND CONDITIONS

- Civil, Furniture, Electrical & AC Contractors shall apply for empanelment in prescribed format. The tender document is available on our website "www.bankofmaharashtra.in" under notices Tenders. The interested applicant shall download the tender and submit their application as per the eligibility. Applicant has to submit the tender along with prescribed fee of Rs. 1,000/- which is non-refundable. No hard copy will be issued in any case.
- 2. Categories for Empanelment.
 - i. Category A Works upto 25.00 lacs
 - ii. Category B Works upto 20.00 lacs
 - iii. Category C Works upto 15.00 lacs
 - iv. Category D Works upto 05.00 lacs
- 3. Intending Civil, Furniture, Electrical & AC contractors are requested to furnish details about their firm, technical experience, competence and evidence of their financial standing as per enclosed Performa for considering their names for empanelment.
- 4. The Civil, Furniture, Electrical & AC Contractors should have minimum three years of experience in the respective field.
- 5. Bank of Maharashtra may approach the Contractor's clients, corporations, organizations, etc. to verify their general reputation / competence/credentials etc. If any aforesaid credentials are adverse, than Bank will not empanel such contractors.
- 6. Selection of contractors for empanelment shall be based on the ability, competence and general behaviour & approach towards work which is to be required for good quality jobs to be performed by them.
- 7. Bank of Maharashtra reserves the right to accept or reject any application without assigning any reason.
- 8. The empanelment shall be made for a specific category. However, contractor empanelled in higher category shall be eligible for the works in the lower category also. However, those who have empanelled in lower category will not be eligible for higher category of work. If any applicant has applied for higher category and if he is not suitable than Bank may consider for lower category. However, decision in this case will be at Bank's discretion.



- 9. If the space provided in the Performa is insufficient for giving full details, the same may be given on a separate sheet of paper. Information furnished to Bank will be kept as strictly confidential.
- 10. Decision of Bank of Maharashtra regarding selection of contractors for empanelment will be final and binding and no further correspondence will be entertained. Contractors empanelled will be informed separately.
- 11.Intending contractors / consultants / vendors / manufacturer are requested to read the Performa carefully before filling the particulars.
- 12. Incomplete applications will not be considered.
- 13. Information / details furnished by selected Contractors, if found to be false at any time in future or any information affecting empanelment is willingly / unwillingly withheld, if come to the notice of the Bank at any point of time, the empanelment of Contractors can be cancelled immediately.
- 14. Wherever required, only certified copies should be submitted. The completion certificate shall be from main client only. Work order copy without completion certificate will not be considered as a proof of the completed work. The completion certificate submitted by subcontractor or obtained from Architect will be not be considered valid.
- 15. Cost of the application form is Rs. 1,000/- which is not refundable & to be paid by way of Demand Draft favouring "Bank of Maharashtra" payable at PUNE.
- 16. Application form is not transferable.
- 17. Empanelment of the firm, if selected, will be valid for 2 years and extendable further period of 01-year subject to satisfactory performance of the contractor.
- 18. The application shall be submitted strictly in the format as mentioned along with the supporting documents.
- 19. The application shall be signed by the person/s on behalf of the organization having necessary Authority/ Power of Attorney to do so. Each page of the application shall be signed as token of acceptance of the contents mentioned therein and copy of Power of Attorney / Memorandum of association (Wherever applicable) shall be furnished along with application. If any application is found without signature on all pages than Bank shall summarily reject the same.



- 20. Completed empanelment document shall be submitted in person up to 4.00 pm on or before 30.09.2023 to the Zonal Manager, Bank of Maharashtra, 1st floor, Jai Kartar Bhawan, Ferozpur Road, Ludhiana. The application shall not be accepted by post / courier. Each application/form must accompany Demand Draft of Rs. 1,000/favouring Bank of Maharashtra and payable at Ludhiana. The application form submitted at any other Dept. or dropped in any box and if not received within stipulated time will be summarily rejected.
- 21. It is necessary that Contractors must have office in the state/UT or a full-fledged branch office in the state/UT of Punjab/J&K and Ladakh, if its head/registered office is at somewhere else. Applicant shall submit necessary address of branch/office located at Punjab/J&K and Ladakh. If Contractors doesn't have office/branch office in Punjab/J&K and Ladakh, they shall provide undertaking that they will make necessary arrangements (men, material & technical staff) for execution of work, if any awarded.
- 22. If any Bidder has two firm or he is in any capacity in other firm and both firm has applied for empanelment than any one firm will only be empanel among two or more firm.
