Minimum Eligibility criteria

- 1) The firm should have successfully completed interior work of at least one Administrative office / controlling office / Zonal Office premises of a Nationalized Bank having minimum area of 3000 sq.ft. and
- 2) The firm should have successfully completed interior work of minimum six branch premises of a Nationalized Bank during last three years.

Scope of Work

Preparation of at least three preliminary layout drawings for approval.

Preparation of detailed Electrical , Data/Network & Interior works drawings .

Preparation of Tender documents (including calculating electrical load and replacing main supply cable etc), Issuing tender documents, Scrutiny of tenders. Submitting comparative analysis.

Day to Day supervision, Regular visits to branch/site , execution of work as per the tender specifications (No extra charges will be paid for day to day visit to branch/site) , verification of materials, measurements, quantities, certifying the bills for payment , maintaining time schedule & completing the work as per time schedule..

Mode of Payment

No advance payment will be made , 90% - on the basis of bills certified ,
10% - Retention will be deducted & kept with us during defect liability period.
