Bank of Maharashtra, Zonal office Jaipur, Invites expression of interest (EOI) from original Equipment Manufacturer (OEM vendors) / Authorized vendors for empanelling them for the supply of SMF/Tubular ups batteries to our branches in Rajasthan for the period of 03 years i.e. from May-2017 to April-2019. The eligibility criteria for the assignment are given below.

Eligibility Criteria

1. The firms who manufactures the batteries (OEMs)/channel partner with manufacturer/ authorized dealers are eligible to participate for this Empanelment.
2. The OEM/channel partner/ authorized dealers must be a registered company or firm in India and should have been in the business in India from the last three years. The company/firm should have been net profit earning company for last 2 years i.e (F.Y. 2015-16 & 2016-17). Audited balance sheet for the mentioned financial years should be submitted.
3. The OEM shall have minimum annual turnover of Rs. 2.0 crores in last financial year i.e FY 2016-17.
4. The production unit / factory of the brand of Batteries being quoted should be ISO 9001, 14001 & UL certified. Relevant copy of the certificate should be enclosed along with technical bid. The OEM/channel partner/ authorized dealers who have quality assurance certificates such as CE, ISI for their batteries can only participate in this tender.

5. The OEM/channel partner/ authorized dealers shall produce a self-declaration that there are -
 - (a) no vigilance and / or court cases pending against it
 - (b) no inquiry or investigation pending against it from any statutory regulatory and / or investigation agency and
 - (c) Has not been blacklisted by any public sector organization in last 3 years.

General Terms and Condition.

1. The empanelled list of OEM/channel partner/ authorized dealers. will be valid for the period for three year starting from May-17 to April-19.
2. The empanelled OEM/channel partner/ authorized dealers has to supply the SMF/Tubular batteries as per Bank's requirement to branches in Rajasthan.
3. The RFP/RFQ will be issued for the supply of SMF/Tubular batteries to only empanelled OEMs during the empanelment period.
4. The OEM/channel partner/ authorized dealers should submit all the relevant supporting documents as a part of submission. All such documents should be sealed and signed by the Authorized Signatory.
5. If, any information furnished by the OEM/channel partner/ authorized dealers is found incorrect at a later date, he shall be liable to be debarred from participating in any of the bidding process of the bank. The bank reserves the right to verify the particulars furnished by the applicant independently.
6. Response to EOI should be submitted in Sealed Envelope. The sealed envelope should be superscribe " Expression of Interest – SMF Batteries " and addressed to :-
