

## Eligibility Criteria for RFP # 182020

The Bank will examine the Eligibility Criteria compliance for the bidder and OEM as per the below tabulated criteria in this RFP. The Bidder(s) and OEM's who satisfy the eligibility criteria conditions shall be considered for the next phase of evaluation viz. Technical Evaluation.

The Bidder / OEM is required to meet ALL the following eligibility criteria applicable to them and provide adequate documentary evidence for each of the criteria Stipulated below:

1	The proposed OEM solutions should have been implemented in a minimum of two BFSI organizations in India.  OR  The proposed OEM solutions should have been implemented in a Scheduled Commercial Bank (excluding RRBs & cooperative Banks) in India having more than 1000 branches. In case there are multiple OEMs or multiple solutions from a single OEM, the above clause would be separately applicable for each of the solution.	Credentials from clients in form of Purchase Orders / Contract Agreement / Credential Letters are required to be provided for reference with the Bank.	
2	OEM must be listed Leaders in Gartner Magic Quadrant in at least one published report in last 3 years for Wired and Wireless LAN Infrastructure.	An undertaking letter to be enclosed by the OEM along with the Gartner Report confirming the same.	
3	The proposed OEMs should have presence in India and outside India and should be able to support project in India during the contract period.	An undertaking letter to be enclosed by the OEM confirming the same.

## Note:

All eligibility requirements mentioned above should be complied by the bidders as applicable and relevant support documents should be submitted for the fulfilment of eligibility criteria failing which the Bids may be summarily rejected. Non-compliance of any of the criteria can entail rejection of the offer. Photocopies of relevant documents / certificates should be submitted as proof in support of the claims made for each of the above-mentioned criteria and as and when the Bank decides, originals / certified copies should be shown for verification purpose. - 3. Public/private sector banks mean public/private sector banks in India only.
