- 13) A copy of the tender form along with the enclosures submitted online (also mentioning the UTR No. and the account number through which EMD is remitted) shall be forwarded to the Branch Manager, Bank of Maharashtra, M G Road Branch/Authorized Officer, Zonal Office, Kolkata Zone so as to reach on or before **10.09.2020**.

The sale certificate shall be issued only in the same name in which the tender is submitted.
- 18) The successful bidder would bear all the charges/fees payable for conveyance such as stamp duty, registration fee or any other cost as applicable as per the law. All statutory/non-statutory dues, taxes, rates, assessments, charges fees etc. will be the responsibility of the successful bidder only.
