1. Nature and Object of Online Sale:

2. 3. - b. Auction/Bidding time will initially be for specified period and if bidding continues, the bidding process will get automatically extended five minutes duration of each and kept open till the auction-sale concludes.
- c. 22. Default of Payment:
