Marginal Cost of Funds based Lending Rates (MCLR) for various tenors are given as under:


Sr. No.	Tenor	MCLR w.e.f 07.12.2017 (in %)
1	Overnight	8.10
2	One Month	8.15
3	Three Months	8.20
4	Six Months	8.55
5	One Year	8.65
