On 17<sup>th</sup> March 2015 Supreme Court has given judgment **quashing Central Government's Notification no. 63 dated 04.03.2004 regarding including "Jat" community in OBC category** as under:

"Notification no. 63 dated 04.03.2014 including the Jats in the Central List of Other Backward Classes for the State of Bihar, Gujarat, Haryana, Himachal Pradesh, Madhya Pradesh, NCT of Delhi, Bharatpur & Dholpur Districts of Rajasthan, Uttar Pradesh and Uttarakhand is set aside and quashed".

Accordingly Offer for Employment will not be issued to the candidates selected under "OBC" category and belonging to "Jat" category and their names will be deleted from the list for further recruitment process of "CWE-PO/MT-IV Reserve List".
