2. 3. The intending Bidders/Purchasers are required to participate in the e-auction process at e-auction service provider's website <https://www.mstcecommerce.com>. This Service Provide will also provide online demonstration/training on e-Auction on the portal.
4. The intending participants of e-auction may download free of cost, copies of Sale Notice, Terms and Conditions of e-auction, Help Manual on operational part of e-Auction from e-Bikray-IBAPI portal (<https://www.ibapi.in>).

**17. Bid Multiplier:**

**22. Default of Payment:**
