As per **IBA CIRCULAR NO.CIR/HR&IR/D/G2/2024-25/1823 dated 20/02/2025**, the Dearness Relief applicable on the Bank Employees' Pension has been revised with effect from 01.02.2025 and hence, February 2025 pension is payable with the revised Dearness Relief. The revised Dearness Relief Chart payable for the period February 2025 to July 2025 is given overleaf, for your information.

In respect of all the branches, the pension credited directly to the respective pensioners' accounts from Head Office on behalf of the branches concerned.
