- 1. Valuer should be registered with the Institute of Valuers, as also under section 34 AB of the Wealth Tax Act.
- 2. The empanelled valuer should preferably be member of any one of the professional valuer bodies viz. Institution of Valuers, Institute of surveyors, Institute of Govt. approved valuers, The Indian Institute of valuers.
- 3. The valuers against whom complaints have been registered with the CBI, Serious Fraud Investigation Cell and courts(s), and/or blacklisted by any bank, is not eligible.
- 4. The firm of the valuer and the valuers/associate valuer(s) each should have PANs.

### 5. For Plant & Machinery:

a) He/She should be preferably graduate engineer in mechanical, electrical, electronics, computer, information technology or posses post graduate degree in valuation of plant & machinery from a recognized university or any such equivalent qualification.
