

OTHER TERMS AND CONDITIONS OF OFFER

1. Tenders shall be submitted in the prescribed format for Vehicle only in a sealed cover super scribing **“Tender for purchase of vehicle bearing Regd.No- Mahindra Bolero DI/MP 20/CC/0163”** addressed to: The Zonal Manager, Bank of Maharashtra, Zonal Office, Jabalpur - 482002.
2. Tenderer can submit for one or more, but, **separate tender should be submitted for vehicle** which shall be put in separate sealed cover as mentioned above.
3. Duly completed tender documents shall be submitted to our office at the address given above on or **before 24/07/2023 by 03.00p.m.** Tenders will be opened on 25.07.2023 by 04.00 p.m. onwards in the presence of intending bidders or their Representatives who may be deputed to remain present at the time **of tender opening at 04.00 p.m. on 25.07.2023.** Only one Authorized Representative will be allowed to witness the tender opening. **Tender received late will be rejected.**
4. EMD of sum **of Rs.10000/-** to be deposited by way of DD favoring Zonal Manager Bank Of Maharashtra payable at Jabalpur.
5. The bid amount to be paid by way of cash/DD favoring Bank Of Maharashtra payable at Jabalpur. **The person on being declared to be successful bidder shall deposit 25% of sale price, immediately.**
6. The balance payment shall be paid **within three days** from the date of tender open, failing which, the amount paid & EMD shall be forfeited. EMD paid shall be adjusted while making the balance payment.
7. The successful bidder shall take possession of the vehicle on payment of balance amount within three days.
8. Application not drawn in the prescribed format, not accompanied by application fee/EMD, not presented in the manner prescribed is liable for **rejection.**
9. Bank reserves right to cancel the tender and/or reject any or all the bids received without assigning any reason whatsoever at any stage.
