The intending Bidders/Purchasers are required to participate in the e-auction process at e-auction service provider's website https://www.mstcecommerce.com. This Service Provide will also provide online demonstration/training on e-Auction on the portal.
- 4. The intending participants of e-auction may download free of cost, copies of Sale Notice, Terms and Conditions of e-auction, Help Manual on operational part of e-Auction from e-Bikray-IBAPI portal (<a href="https://www.ibapi.in">https://www.ibapi.in</a>).
- 5. The intending Bidders / Purchasers are requested to register on portal (https://wwwmstcauction.com) using their mobile number and email id. Further, they will upload the requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2-3 working days), the intending Bidders/Purchasers has to transfer the EMD amount using online mode in his Global Wallet. - 6. #### 17. Bid Multiplier:

The bidders shall increase their bids in multiplies of the amount specified in the public sale notice/Terms and condition of Sale.

#### 18. Duration of Auction sale:

- a. Online auction sale will start automatically on and at the time given in the public sale notice/Tender Document.
- b. Auction/Bidding time will initially be for specified period and if bidding continues, the bidding process will get automatically extended five minutes duration of each and kept open till the auction-sale concludes.
- c. #### 22. Default of Payment:
