- 2) The bidder should have average annual turnover of more than 9.00 lakh & should have shown the profits in each of during the last three financial years (Valid CA certificate to be enclosed)
- 3) The bidder should have successfully executed minimum single work of similar type, costing more than Rs.40.00 lakhs during last three years or minimum two works of similar type, costing more than Rs.25.00 lakhs during last three years or minimum three works of similar type, costing more than Rs.20.00 lakhs (Proof of the same should be submitted for having successfully completed the work). The Bidder shall submit the completion certificate from the competent authority of Client.
- 4) The bidder should not have been blacklisted by any PSU Bank or enterprise /Private Bank/NBFC/Co-operative Bank/Govt. department during last 05 years. A written undertaking has to be given by the bidder on their letter head.
