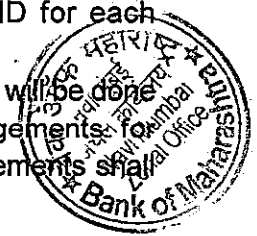

20. Declaration of successful bidder:

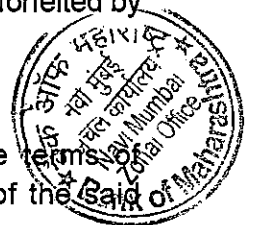

- d. 22. Default of Payment:

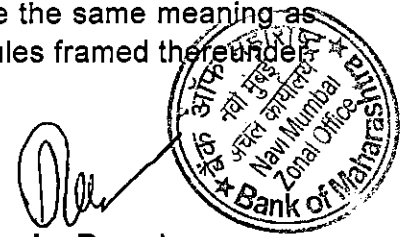
