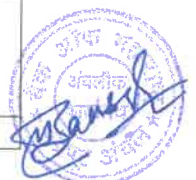

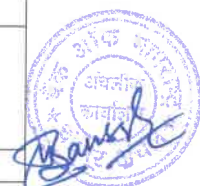

**1. Nature and Object of Online Sale:**

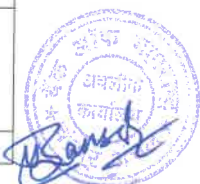

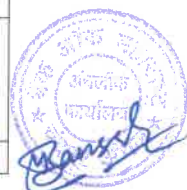
**19. Online Bidding:**

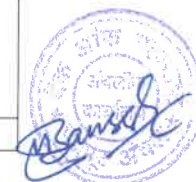
**22. Default of Payment:**

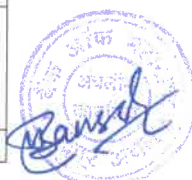
**27. Delivery of possession:**
