# 1. Nature and Object of Online Sale:

- a. The online e-auction sale is with the object of Free and Fair Sale, Transparency and for achieving best-possible recovery of public money.

- 2. - 3. Platform (https://www.mstccoomerce.com) for e-auction will be provided by e auction service provider M/s MSTC Limited having its Registered office as at 225-C, A.J.C Bose Road, Kolkatta-700020(contact Phone & Toll Free Numbers 079-41072412/411/413 or 1800-103-5342). The intending Bidders/Purchasers are required to participate in the e-auction process at e-auction service provider's website https://www.mstcecommerce.com. This Service Provide will also provide online demonstration/training on e-Auction on the portal.
- 4. The intending participants of e-auction may download free of cost, copies of Sale Notice, Terms and Conditions of e-auction, Help Manual on operational part of e-Auction from e-Bikray-IBAPI portal (https://www.ibapi.in).
- 5. The intending Bidders / Purchasers are requested to register on portal (https://wwwmstcauction.com) using their mobile number and email id. Further, they will upload the requisite KYC documents. # 17. Bid Multiplier

The bidders shall increase their bids in multiplies of the amount specified in the public sale notice/Terms and condition of Sale.

### 18. Duration of Auction sale:

- b. Auction/Bidding time will initially be for specified period and if bidding continues, the bidding process will get automatically extended five minutes duration of each and kept open till the auction-sale concludes.
- c. # 22. Default of Payment:

- a.
