**Sub :- Bank Employees' Pension – Revision of Dearness Relief.**

As per IBA CIRCULAR NO.CIR/HR&IR/D/G2/2018-19/6765, DATED 01/02/2019, the Dearness Relief applicable on the Bank Employees' Pension has been revised with effect from 01.02.2019 and hence, February 2019 pension is payable with the revised Dearness Relief. The revised Dearness Relief Chart payable for the period February 2019 to July 2019 is given overleaf, for your information.

All the branches are under CBS and pension is directly credited to the respective pensioners' accounts from Head Office on behalf of the branches concerned.

- (1) All Branches should ensure that Income tax at the prescribed rate is to be deducted from the pension, wherever applicable and remitted into the Government Account in time.
- (2) Further, as per IBA CIRCULAR NO.CIR/HR&IR/D/G2/2018-19/6765, dated 01/02/2019 dearness relief payable for the period February 2019 to July 2019 to Surviving Pre-01.01.1986 Retirees / Spouses of Pre-01.01.1986 Deceased Retirees of the Bank, who are in receipt of Ex-Gratia, is as under:
