Following correction be read in the tender document

### **1) Page No 9 of 80**

#### **4. Scope of work: Revised Time schedule**

Point 6: Timelines increased from 2 weeks to 4 weeks.

### **2) Page No 19 of 80**

#### **34. Revised Adoption of Integrity Pact**

Point 10: A person/entity signing IP shall not approach the court while representing the matters to IEMs and he/she will wait their decision in the matter.

### **3) Page No 24 of 80**

#### **41. Revised Performance Bank Guarantee**

The successful bidder should furnish a Performance Bank Guarantee to the extent of 3% of the value of the contract within 15 days of the date of receipt of the purchase order/Indent. The Performance Bank Guarantee has to be submitted in the format as required by the Bank. The performance guarantee would be for the entire period of the Contract plus 12 months claim period. If the Performance guarantee is not submitted, the Bank reserves the right to cancel the contract. The Performance Guarantee would be returned to the bidder after the expiry or termination of the contract.

The limit of PBG of 3 % is as per guidelines of Ministry of Finance, Department of Expenditure Procurement Policy Division (No. F.9/4/2020-PPD) dated 12th November 2020 which are applicable to all tenders/ contracts issued/ concluded till 31st December 2021. If the tenders/ contracts is not issued/ concluded till 31st December 2021, as per revised guidelines of GOI (if any) will be applicable with regards to PBG. In absence of any guidelines from GOI, the limit of PBG will be 10 %.
