Other Terms & Conditions :

- 1.EMD Rs.20,000.00 , in the form of Demand Draft drawn on any Nationalised Bank favoring Bank of Maharashtra payable at Ahmednagar
- 2.The Contract is initially for one year & Renewable further, subject to satisfactory service.
- 3.Interest Free Security Deposit Rs.1,50,000.00 during entire tenure of contract.
- 4.The firms should have all permissions & licenses (EPF,ESCI,LABOUR,Guard Board, DGR, Police)
- 5.The wages should be as declared by the Office of the Commissioner of Labour, Mumbai.
6. Preference will be given to the firms having 3 years experience & controlling office at Ahmednagar.
- 7.Sealed offers will be opened at 5.30 P.M. on same day i.e. on 09/10/2014 . Interested agencies may attend tender opening process.
- 8.The firms should be in a position to deploy Cash Van & Gunman within short notice.
- 9.The EMD will be forfeited if the short listed firm fails to execute the agreement & within time period.
- 10.The agency should be ISO – 9001/2008 & should have all India/State/Regional network.
- 11.The firms should have sound financial standing & indemnify the bank against any loss.
- 12.The agency should have sufficient insurance cover for the staff & property .
13. Any other requirement made mandatory by the Bank / Govt. machinery should be complied by the agency.
14. The cash Vans should be mechanically fit for duty, preferably new (not older than 5 years) & should have a tie-up with reputed garages for regular maintenance (cost to be borne by agency)
