1. Nature and Object of Online Sale:

Pune. Earnest Money Deposit (EMD) shall be adjusted in case of highest bidder, otherwise refunded within 7 working days of finalization of sale. The EMD shall not carry any interest. 14. Default of Payment:

- a.
