The SARFAESI Act being a central legislation overrides all STATE LEGISLATIONS / ACTS and the rules and regulations framed there under. Advocate concluded his opinion mentioning that bank can conclude the sale of the said flat without obtaining any permission from Municipal Corporation of Greater Mumbai. In view of the above, bank has decided to conduct e-auction of the captioned property in concurrence with the opinions of advocate. c) As per the bill dated 02.03.2020 received from the Chairman of the Housing Society, Maintenance & other charges amount of Rs. 50,503/- (Rs. 17. Bid Multiplier:

18. Duration of Auction sale:
