1. Intending purchaser should submit his offer in sealed cover superscribed as **“Offer for purchase of Vehicle”** addressed to Zonal Manager, Bank of Maharashtra, Zonal Office Ahmedabad, Mavalanker Haveli, Vasant Chowk, Bhadra, Lal Darwaja Ahmedabbad 380001.
2. **The offer should be specific and with quoting the vehicle number.**
3. The offer for vehicle should accompany EMD of Rs.29,000/-for Maruti Swift VXI & 15,000/- for Mahindra Maxx (BSIII) Cash Van for General Public and Rs.10,000/- for staff members / retired staff members in the form of Demand Draft favoring Bank of Maharashtra payable at Ahmedabad.
