Yogi lays base of Queen Ho memorial

Pressing on the cultural relations between India and South Korea, Chief Minister Yogi Adityanath said that both the countries enjoyed very old ties with yodhya acting as a binding force between the two.

Addressing people while laying the foundation stone of memorial of Queen Ho in yodhya, the CM said that round 2000 years ago, a princess from Ayodhya got married to a prince of South Korea. He reminded people that the bond created at that time had been revived by the first lady Kim Jung-sook by her presence in the function.

As per relations, we have Ayodhya is the maternal (mother's parental house) of South Korea and we welcome the first lady and the high level delegation of South Korea in their 'nanihal'. Yogi said as people shouted 'Jai Sri am.
