## Boost clean energy, cut emission, or see economy dip: Goyal

POWER MINISTER PIYUSH Goyal on Monday underlined the importance of quickening efforts to promote clean energy and reduce greenhouse gas emission failing which

the global economy will slip into deceleration. The minister spoke of 3Ds - de-carbonisation, more decentralisation and greater digitisation.

"With each passing day, we are running out of time and we need to accelerate our efforts in coordination to promote clean energy and reduce greenhouse gas emissions. If we do not address these 3Ds, I am worried that the world might end up decelerating the global economy," the power minister said while addressing the 8th World Renewable Energy Technology Congress here.

India, according to Goyal, is taking steps on the global platform to address the challenge, which include the International Solar Alliance (ISA), the Mission Innovation, global engagements on rapid de-carbonisation of the energy space, the African Renewable Energy initiative, efforts by G20 energy ministers.

The minister noted that the past 10-15 years have seen a rapid decline in the quality of atmosphere due to increasing greenhouse gas emissions globally and it has become "probably the largest challenge" today "Post the Paris agreement, the world as a whole has recognised that climate change is a serious issue and needs to be addressed globally in a mission mode," the minister added.

The annual conference kicked off against the backdrop of India's vision on achieving 'Energy Independence and Power for all by 2022'.

It focuses on new green technologies to ensure clean, reliable and affordable renewable power and provides an opportunity and open forum to exchange information, share experiences and best practices by bringing together experts, investors and other stakeholders.

## GST pulls down India Inc's Q1 net by 15.7%: Report

2,108 companies by credit rating agency Care Ratings, the corporate net profits stood at about ₹1.04 lakh crore in April-June period of 2016-17. Besides, net sales of compa-

nies slowed down to 8.7% in the three months ended June 2017, after registering a growth of 9.5% in the same period a

"During the first quarter of 2017-18, all companies faced the heat of the uncertainties revolving around the implementation of goods and services tax (GST) by the government as most companies were destocking goods before July 1 and operations were impacted quite markedly," Care Ratings said.

As many as seven industries reported net loss, while 33 segments reported lower growth in net profit on a year-on-year basis during the quarter ended June 2017.

The maximum drop was seen in consumer goods, automobiles and related segments, construction & real estate, finance, refineries, paper & paper products, pesticides & agrochemicals sectors. The profitability of services sector like
