RECRUITMENT OF PART TIME SUBSTAFF

In continuation of our advertisement for recruitment of Part Time Sub-Staff, this is to inform that Bank has scheduled the written test on 09.09.2018. Through Bank's website, Provision to down load the call letter for written test shall be made available for the eligible candidates.

The Bank has modified the structure of written Test, which is as under.

** As per govt. guideline 5% relaxation in qualifying marks for reserved category SC/ST/OBC/PWD is extended.

The candidates are advised to note the changes carefully.

The above tests except the knowledge of English Language and local language will be available bilingually i.e. English and Hindi.

Provisionally selected candidates will be further subjected to the assessment of their capability to read and write in local language. Following modalities will be applicable for such assessment.

- The merit list shall be prepared as per the rank of candidate as stipulated in Clause No.1 & 2 of 'written test processes' as appearing in the website advertisement dated 10th June 2017.
- The ability to read and write in local language shall be assessed only of successful candidates in the ratio of 1:5 (5 candidates for each vacancy) as per the rank assigned district wise. E.g. in respect of Wardha district as regards vacancies identified for un-reserved category, candidates ranking 1 to 5 in the said district list will have to undergo local language capability test. In case all the candidates within these rank fail to qualify the test, the candidate ranking 6th will be invited for the test and so on and so forth. Similar process will be followed in respect of other districts.
- If the candidate concerned (shortlisted as per (b) above) has passed his minimum educational qualification examination in local language or had local language as one of the subjects in the syllabus of such exam, then the candidate shall be treated as capable of reading and writing in local language.

- d) If the shortlisted candidate do not qualify under clause 'c' above then the candidate will have to undergo capability assessment in respect of reading and writing in local language in the presence of such authority or panel of authorities either from within or outside the Bank, as may be designated by the competent authority of the bank in its sole discretion. The modalities for such assessment will be decided by the bank as its sole discretion. Final selection of the candidates shall be subject to successful assessment and the decision of the bank in this regard shall be final and binding.

- e) Candidates failing in local language test administered as per clause 'c' or'd' above as the case may be shall not be considered for recruitment and for such vacancies the assessment of the next lower rank holder as per the merit list, shall be done as per clause 'c' or'd' as the case may be for selection for the post as above.

All other things remain the same as per the advertisement dated 10.06.2017.
