

Munde was caught red-handed taking bribe at guest house in Ahmadnagar

Under PCA, the maximum and minimum imprisonment have been prescribed, but there is no ceiling on it. It is left to the judge's discretion," he said. Ashok Keshavrao Munde, attached to the Shrirampur panchayat amiti, was caught accepting a bribe of

Rs 1.5 lakh from a contractor on May 4, 2016, said ACB deputy superintendent Vishnu Tamhane. Munde had demanded 5% of a bill amount to release a cheque. It had been agreed that the complainant would hand over the bribe to Munde at the Ahmadnagar zilla parishad guesthouse. Munde was caught red-handed.

Offences under the Prevention of Corruption Act were registered, and the investigating officer, then deputy superintendent Irfan Shaikh, completed the probe in record time and submitted the chargesheet on September 2, 2016. Delivering the verdict on Friday, Ahmadnagar sessions judge S U Baghale sentenced Munde to 10 years' rigor-

ous imprisonment and handed a fine of Rs 50 lakh for offences under PCA Section 13 (criminal misconduct by a public servant and abuse of official position). Further, he imposed seven years' rigorous imprisonment and a fine of Rs 35 lakh under Section 7 (public servant accepting bribe). The prison terms will run concurrently.
